Barrie Wyland made a motion to accept the minutes as written, second David Bigelow. Unanimous

Any further development up there and new approved roads will be up to the land owners expense before township will consider taking over the road, second David Bigelow. Unanimous

Ralph F Rispoli made a motion to accept Ordinance 62 Establishing the Amount of Compensation for Catharine Township Supervisors, second David Bigelow. Unanimous

David Bigelow made a motion to accept going with the other municipalities to participate in the joint advertisement for the Ordinance to enact the Earned Income Tax, second Barrie Wyland. Unanimous

Ralph F Rispoli made a motion to accept the mileage rate increase from 51 cents to 55.5 cents as of September 12, 2011, second David Bigelow. Unanimous

Ralph F Rispoli said Robert Bottenfield would like to go to an Auditors Seminar and asked if the township would reimburse him. Barrie Wyland made a motion to reimburse for his cost, second David Bigelow. Unanimous

Eleanor K Harclerode has been trying to get her hours down. Eleanor said she has been working around 14 to 18 hours a week since everything except bank statements is completed. Eleanor asked if that is too many hours. Eleanor said that she is not sure how it will be for the month of January when forms need filled out, routine work, quarterlies, W-2, and reports and information ran for the auditors before January 31. Also, if I need to help the auditors I'm not sure how many hours that will take. Eleanor said she would try to do her best to keep hours down.
