A motion was made to accept the minutes as written on November 12, 2013 by Ralph F Rispoli, seconded by Marc Daniel Isenberg. Unanimous

A motion was made to accept the minutes as written on November 25, 2013 by Ralph F Rispoli, seconded by Marc Daniel Isenberg. Unanimous

A motion was made to accept the financial report as given by Ralph F Rispoli, seconded by Marc Daniel Isenberg. Unanimous

Subdivision and Land Development Ordinance - A motion was made by Ralph F Rispoli that a Non-Building Subdivision does not have to go to Keller Engineers for review, seconded by Marc Daniel Isenberg. Unanimous

Ralph F Rispoli asked the secretary to only make one copy of everything instead of making a copy for each supervisor.

Eleanor K Harclerode was told today that Dale Ray is trying to get a permit at the hotel that he owns, and it was denied by CCIS. Joseph Lansberry asked if I would ask Ralph F Rispoli if he knew anything about an approval board committee for the code inspection service back in 2004. Each Township and Borough was to appoint someone to serve on the board.
