The board of supervisors for Catharine Township met on Monday, July 13, 2015, at the Catharine Township Building with supervisors Ralph F Rispoli, Marc Daniel Isenberg, Kenneth Brenneman, secretary Eleanor Harclerode, and roadmaster Michael Fay present.

Visitors: Bruce Estep and Daryl Cole

Bruce Estep said that Marshall Dicken's property is getting worse. Bruce doesn't understand why Mr. Gibboney and the township can not do anything about this problem. Bruce said Marshall has vehicles setting within 150 feet of a natural stream, junk vehicles within 75 feet of a township road, and 25 feet from the property line. They should not be visible to other property owners. Bruce said he had a demolition car which he is running round and round all afternoon. Bruce said that one night Marshall was using a chisel and grinder to cut up a car for demolition. Bruce said he called the state police, and no one came. Marc Daniel Isenberg said he has been up different times, and is continuing to check. Marc Daniel said the same situation still continues but by moving vehicles and so forth around makes it look different each time. Supervisors said to call the solicitor and have him come back down to check it out again.

Michael Fay said that he is checking about doing French Drains on Edgewood Drive.

Ralph F Rispoli commented about septic inspection within the next couple of years.

Daryl Cole said that about two weeks ago he was asked about the capacity of the sewer plant and right now it is around 50 percent. Daryl said the sewer plant should be able to pick up Ganister. The only thing is getting across the river and hocking into the sewage line. They would probably have to put a pump station or grinder to pump it up to go through the line.
