Resolution# 2014-02 – PSATS asked the township to pass a budget resolution that notes the receipt of the money, the amount of \$145.17, and where it will be allocated, if known, or note that it will be allocated as part of the 2015 budget from Marcellus Shale. A motion was made by Kenneth Brenneman to accept Resolution# 2014-02, seconded by Marc Daniel Isenberg. Unanimous

Resolution#2014-03 – The Township needs to put a resolution into place for adopting Catharine Township's sign maintenance policy. A motion was made by Kenneth Brenneman to accept Resolution# 2014-03, seconded by Marc Daniel Isenberg. Unanimous

Public Meeting for Bridge Replacement – PennDot would like to set up a date and time to go over plans to replace the bridge on route 22 and 2015 that involves a detour. Supervisors said a Tuesday or Thursday meeting would be good for them, but prefer Tuesday.

NIMS – Emergency Management would like to remind us that the Supervisors, Roadmaster, and Secretary need to take the 100 and 700 Class. The classes are mandated. If we do not take the classes we can eventually be shut off from FEMA or PEMA

Reassessment – Eleanor Harclerode said she went to the meeting they had in Altoona. They said 1/3 will go up, 1/3 will go down, and 1/3 will stay the same. When they are done, the first year taxes have to stay the same as now. We will have to adjust the percent. They would like reassessment done by July 2016. They will not be going through your home. They will be giving you a questionnaire to fill out and send back. You can go on Blair Co web site for information at www.blairco.org.

Ralph F Rispoli asked if we need to appoint a code enforcement officer. Some residents are not getting building permits for swimming pools, making changes to their property, any new construction, floodplains, setbacks, or how far from another building you can build.

- 1. Mrs. Shock Trees branches are too close to the roads. She has agreed to cut the trees down.
- 2. Randy Bigelow Pipes across the road at their place and about putting drain boxes down along the road to the cross pipe.
- 3. Worked one day at Rails to Trails
- 4. Agility Fox Run water running by Barry England's house
- 5. Log Cabins—Sharp curve by the cabins at Mt Etna need a pipe extension. PennDot wants to know if we can do it under the agility program.
- 6. Williamsburg Borough, Woodbury, Huston, and Catharine Winter Maintenance 8:00 to 3:00 Late September early October
- 7. Dave Cambridge About taking over plowing Yellow Spring Rd. Yellow Spring Rd is 4.2 miles at \$2,200.00 mileage comes to about \$9400.00. Fox Run 10.6 miles and would come roughly \$20,000.00 under the winter agility program. That money would go to the township.
