

MINUTES FOR THE June 9, 2014 MEETING OF THE CATHARINE TOWNSHIP BOARD
OF SUPERVISORS

The board of supervisors for Catharine Township met on Monday, June 9, 2014, at the Catharine Township Building with Ralph F Rispoli, Marc Daniel Isenberg, Kenneth Brenneman and secretary present.

Visitor: John Clabaugh from Stiffler, McGraw, Wayne and Norma Grove, and Curt Bookhammer.

Kenneth Brenneman made a motion to accept the minutes as written, seconded by Ralph F Rispoli. Unanimous

Marc Daniel Isenberg said he found a couple mistakes on the minutes.

1. Roadmaster Report number 3 – The person who purchased the items.
2. Roadmaster Report number 4 – Just needs reworded.
3. First page add last month in the sentence about the Supervisors tabled it until all three were here.

A motion was made by Kenneth Brenneman to correct the errors, seconded by Marc Daniel Isenberg. Unanimous

A motion was made by Kenneth Brenneman to accept the financial report as given, seconded by Marc Daniel Isenberg. Unanimous

Airport Hazard Area Conflict Mitigation Ordinance #68 – A motion was made by Marc Daniel Isenberg to accept the Airport Hazard Mitigation Ordinance #68, seconded by Kenneth Brenneman. Unanimous

Curt Bookhammer questioned about putting a private driveway in Catharine Township right next to Brenneman's Property which will access three properties to Rt22. Curt said there will be a subdivision coming in the next few months.

John Clabaugh – John Clabaugh came to give us an update on the sewer project and Recreation Drive. There are some issues:

1. Keeping up with the pot holes on Recreation Drive.
2. When would the Paving Permit be done? They are almost done with part one. They will be changing the flow over to the new plant so they can start part two demolishing the old plant and bringing the dirt up to the plateau with the rest of constructions. The middle of the building will be an office, billing window, bathroom, and room for doing testing. Right hand side will be the slug processing building. Left side will be a work shop.
3. When this is all done, then they will do paving on Recreation Drive. They want the paving done by the end of this year. September 19, 2014 is their ending date. John doesn't think they will be done by then. They are running a little bit behind. If the road does not get paved this year, they will do something to hold it until next spring. It will

come down to if the township wants the contractor from the sewer project to pave Recreation Drive. He is talking about just the spots that are damaged or if the township would take the money and do it them self. That will be discussed later when the time comes to do the paving, how much damage is done, and if the township has the money to do all of Recreation Drive.

Public Meeting for Bridge Replacement – PENNDOT would like to set up a time for them to come and go over the detour for the bridge in July. The supervisors said to have the secretary set up a day and time. The best time would be on a Tuesday or Thursday evening at 7:00 PM. Secretary is to check into the Farms Show Building or Community Center.

Pa Public Utility Commission – Catharine Township will be receiving \$145.17 from the PA Public Utility Commission disbursement for 2013 Marcellus Shell.

Blair Co Commissioners – Will be holding their first public meeting on Tuesday June 10, 2014 at 7:00 PM at the Blair Co Convention Center on “Understanding Reassessment”.

Donation - The Williamsburg Recreation Committee sponsors morning recreation programs during the summer for boys’ and girls’. They participate in area basketball leagues, the Williamsburg summer recreation programs, equipment at the Riverside Park, and etc. The supervisors tabled this until someone comes and talks to the board.

Teresa Matterns that works for Mattern House/Ganister Station wanted to know if she would have to get a permit to put a sign up on her property. She wants to cut two trees down by the parking lot and put the sign there. Supervisors said because the sign is on her property and not on the state or township right a way, she will not need to get a permit.

Resident says he got a building permit and he did not. Michael Fay said he will call Randy Stoltz and talk to him.

Kenneth Brenneman said he had some issues:

1. Stanley Loose wanted to see about getting a riding mower.
2. Resident complaining about stumps being removed.
3. Wanted to know how the tractor repair axle went.

Roadmaster Report:

1. First mowing should be done this week.
2. Rails to Trails wanted to see about Catharine Township mowing along both sides of the trail. Marc Daniel Isenberg said if they pick up the fuel, and Mike Fay volunteers his time, there will be no problems.
3. Rent the Jack Hammer and air compressor
4. Penn DOT – Turnback for Fox Run Road. Wanted to see if we would be interested in taking it over as a township road. They would pave it first and then turn it over to us. Mike Fay figured there would not be enough money to cover the road later when it would

- need paved again. Supervisors said we would just plow the road in the winter.
5. A request to pave Lower Polecat Road.
 6. Oil and Chip - J R Road
 7. Inventory for signs by June 13. We agree to expected signs. Changing signs when they need replaced.
 8. Check out account 438
 9. Need to know by September if township is plowing Yellow Spring Road

Marc Daniel Isenberg made a motion to pay bills, seconded by Kenneth Brenneman.

Marc Daniel Isenberg made a motion to adjourn, seconded by Kenneth Brenneman.
