OLDINANCE NO. 4

Amending Township Ordiname No. 1, enacted on July 3, 1952, by changing the boundaries of the sewer district established by said ordinance.

BE IT ORDAINED AND ENACTED by the Supervisors of Catharine Township, Blair County, Pennsylvania, and it is hereby ordained and enacted by authority of the same:

Section 1. Section 1 of Catharine Township Ordinance No. 1, adopted on July 3, 1952 is hereby emended so that the sewer district established thereby shall hereafter be known as "Robeson's Extension Sewer District" and shall include the area within Catharine Township bounded as follows:

Beginning at the Northeastern corner of the intersection of Home Street and Hill Alley; thence along the Eastern line of Hill Alley a distance of one and one-half blocks to the Northwest corner of Lot No. 5 in Block "D"; thence along the Northern line of said Lot No. 5 in Block "D" in an Easterly direction a distance of one-half block to the Eastern line of Plum Street; thence along the Eastern line of Plum Street in a Northerly direction a distance of three lots to the Northwest corner of Lot No. 18 in Block "B"; thence along the Northern line of said Lot No. 18 in Block "B" in an Easterly direction a distance of one-half block to the Eastern line of Oak Alley; thence along the Eastern line of Oak Alley in a Northerly direction to the Northwest corner of the American Legion property; thence in an Easterly direction along the Northern line of the American Legion property a distance of one-half block to the Western line of High Street; thence along the Western line of High Street in a Southerly direction to a point opposite the Northwestern corner of Lot No. 6 in Block "I"; thence in an Easterly direction along the Northern line of said Lot No. 6 in Block "I" a distance of one-half block to the Western line of an Alley; thence along the Western line of said Alley in a Southerly direction a distance of approximately three blocks to a point at the Southeast corner of Lot No. 4 in Block "P"; thence along the Southern line of said Lot No. 4 in Block "P" in a Westerly direction a distance of one-half block to the eastern line of High Street; thence along the Eastern line of High Street in a Northerly direction axist to the Northeast corner of the intersection of High Street and Home Street; thence along the Northern line of Home Street in a Westerly direction a distance of one and one-half blocks to the point and place of beginning. See Blair County Plot Book Vol. 3 at page 60 and Vol. 5 at pages 49, 51 and 53.

Section 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall be effective immediately upon its advertisement and recording according to law.
