

ORDINANCE NO. 22-

AN ORDINANCE OF CATHERINE TOWNSHIP AUTHORIZING the CREATION AND ADJOINING OF THE ORIGINAL PLANNING COMMISSION WITH THE BOROUGH OF WILLIAMSBURG AND WOODBURY TOWNSHIP, AUTHORIZING THE EXECUTION OF THE ARTICLES OF AGREEMENT

WHEREAS the Pennsylvania Municipalities Planning Code Act No. 247, Article 11, approved the 31st day of July, 1968, authorizing the governing bodies of two or more municipalities to authorize the establishment of membership in and support of a joint municipalities planning commission.

AND WHEREAS the governing bodies of Catherine Township, the Borough of Williamsburg and Woodbury Township are desirous of establishing and participating in a joint municipalities planning commission to be called, The Williamsburg Area Planning Commission, which shall be a separate and distinct body from any planning commission heretofore created by Catherine Township.

THEREFORE, be it ordained and enacted by the Board of Supervisors of Catherine Township, Blair County, Pennsylvania, and it is hereby ordained and enacted by authority of the same as follows:

SECTION ONE: Supervisors of Catherine Township do hereby authorize the establishment and participation or membership in and support of a joint municipal planning commission with the Borough of Williamsburg and Woodbury Township consisting of 9 members, 3 of whom shall reside within Catherine Township and to be appointed by Supervisors of said Township, 3 within the Borough of Williamsburg and to be appointed by Council of said Borough, and 3 of whom shall reside in Woodbury Township to be appointed by the Supervisors of said Township, which commission shall be known as the Williamsburg Area Planning Commission.

SECTION TWO: Members of said commission shall be appointed by the Supervisors of Catherine Township for 2 years, 1 member for 3 years and 1 member for 4 years. Thereafter, as the foregoing terms expire, members of said commission shall be appointed for a term of 4 years, appointment to fill a vacancy shall be only for the unexpired portion of a term. Each member of the Williamsburg Planning Commission shall be entitled to one vote.

SECTION THREE: Any financial assistance required by the Williamsburg Area Planning Commission shall be provided as follows: One-Third by Catherine Township, One-Third by the Borough of Williamsburg, and One-Third by Woodbury Township.

SECTION FOUR: Appropriate officers of Catherine Township are hereby authorized to execute the Articles of Agreement with the Borough of Williamsburg and Woodbury Township, formally establishing the Williamsburg Area Planning Commission.

SECTION FIVE: The Williamsburg Area Planning Commission shall have all the powers, privileges, duties and responsibilities conferred by said Act of 1968, July 31st, P.L. 805, Article 11, and such other duties as the governing bodies of the respective creating municipalities may, from time to time, determine.
