## ORDINANCE NO. 34

AN ORDINANCE TO TAKE OVER, ACCEPT, AND MAINTAIN AS TOWNSHIP ROADS CERTAIN PORTIONS OF PUBLIC ROADS WITHIN ROBESON'S EXTENSION TO THE BOROUGH OF WILLIAMSBURG, CATHARINE TOWNSHIP, BLAIR COUNTY, PENNSYLVANIA; DIRECTION TO FILE A COPY OF THE ORDINANCE AND SURVEY WITH THE PROTHONOTARY OF THE COURT OF COMMON PLEAS OF BLAIR COUNTY; AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, the Board of Supervisors of Catharine Township can in accordance with the Second Class Township Code, Act of May 1, 1933, P.L. 103, Article XI Section 1101 et seq, as amended, 53 P.S. Section 66101 et seq, enact ordinances surveying, laying out, opening, widening, vacating, and accepting roads and parts thereof within the Township; and

WHEREAS, it has been determined in the judgment of the Board of Supervisors that it is necessary for the public convenience for Catharine Township to take over as a Township Road, the sections of roads hereinafter described; and WHEREAS, said roads have been used and maintained by the Township for a period of twenty-one (21) years; and

WHEREAS, due notice having been given and public hearing having been held in accordance with the Second Class Township Code, Article VII, Section 702, as amended, 53 P.S. Section 65741,

NOW, THEREFORE, BE IT ENACTED by the Board of Supervisors of Catharine Township:

Section 1. The following portions of roads are taken over and accepted as a part of the road system of Catharine Township:

RECREATION DRIVE: Beginning at the northern intersection of Recreation Drive (T. 601) with Chestnut Street (T.467), also known as 2nd Street, thence along the right of way of Recreation Drive north 10° 26' west to its intersection

with Walnut Street (T.468), also known as 3rd Street, thence in the same course to its intersection with Locust Street (T.469), also known as 4th Street, thence in the same course to its intersection with L.R. 260, also known as S.R. 2015.

<u>PLUM STREET</u>: Beginning at the northern intersection of Plum Street (T.452) with Chestnut Street (T.467) thence along the right of way of Plum Street north 10° 32' west to its intersection with Walnut Street (T.468).

WALNUT STREET: Beginning at the eastern intersection of Walnut Street (T.468) with Plum Street (T.452), thence along the right of way of Plum Street north 80° 44' East to its intersection with L.R. 260 also known as S.R. 2015; and from the eastern intersection in the same course to its intersection with Recreation Drive (T.601).

LOCUST STREET: Beginning at the Oak Alley dead end of Locust Street (T.469) thence north 79° 30' East to its intersection with L.R. 260 also known as S.R. 2015; and from the eastern intersection in the same course to its intersection with Recreation Drive (T.601)

As is more fully set forth in the attached Exhbiit "A".

Section 2. The Township Solicitor is directed to file a certified copy of this Ordinance and Exhibit "A" in the Office of the Prothonotary of the Court of Common Pleas of Blair County, and two certified copies thereof with the Department of Municipal Services, Commonwealth of Pennsylvania, Department of Transportation.
