A motion was made to accept the minutes after some changes were made by David Bigelow, seconded by Ralph Rispoli. Unanimous

A motion was made to accept the financial report as given by David Bigelow, seconded by Marc Daniel Isenberg. Unanimous

Secretary received the form to fill out to bond Recreation Drive. Forms will be filled out on April 09, 2013.

Rick and Sharon Baker would like to extend their road bond until June 30, 2013. Keller Engineer said there should be no problem. The only paper that needs signed again is the permit.

Point View Modules – Came back incompleted again, and we have not heard from anyone.

Septic System – Luke Helsel stopped and inspected our septic tanks for this year, and everything is OK.

Williamsburg Public Library – Marc Daniel Isenberg made a motion to give a donation of \$1,000.00 to the Williamsburg Public Library, seconded by David Bigelow. Unanimous

Michael Fay was concerned if he would be able to sit on the Williamsburg Municipal Authority Board. A letter from Allen Gibboney clarified that Michael Fay is properly now constituted as a member of the Williamsburg Municipal Authority Board.

David Imler gave the secretary papers to past on to the supervisors. David Imler wanted to know if the secretary received any District Magistrate Judgments, and the secretary said "no". The only papers the secretary received were receipts from Allen Gibboney.

Williamsburg Area Fire Commission Report – The supervisors received a report showing all of the calls received by 911 dispatch for the calendar year of 2012. The report indicates the types of calls in the month they were reported. There is a graph showing that 43 calls were for incidents in Catharine Township.

2012 Audit Report is here for review. Ralph Rispoli asked if there were any problems with the audit. The auditors asked about payroll liability taxes. DCED was called twice, and we never received a call back.

H A Thomson about insurance – If Mike Fay would use his backhoe, would he be covered? As long as Mike Fay is on the clock he is covered. Mike Fay's backhoe would not be covered unless he has insurance on his backhoe himself.

David Bigelow asked about building permits. Residents are to get a building permit from the township from 100 Sq Ft up to 1,000 Sq Ft. Over 1,000 Sq Ft the resident is to get a building permit from CCIS. Applications can be picked up at the township.
