The board conducted an open discussion with PA-DEP representatives and other visitors regarding an Act 537 Plan for Catharine Township and the Township's intent to connect Ganister to public sewer. The board also discussed potential sources of grant funding.

David Cunningham from Keller Engineers spoke and advised the board that the first step in the Ganister project is to send a planning mailer to Rick Barrett for Ganister Planning. The next step will be to schedule a meeting with Williamsburg Authority to discuss specifics.

A motion was made by Ralph F Rispoli to pay the notary fee of \$140.00 to transfer the 2005 Int'l Dump/Plow Truck title, seconded by Heather Flaig. Unanimous

A motion was made by Ralph F Rispoli to accept Loranne Keithley's resignation, seconded by Heather Flaig. Unanimous

A motion was made by Kenneth Brenneman to appoint Eleanor Harclerode as Township Secretary/Treasurer, seconded by Heather Flaig. Unanimous

A motion was made by Kenneth Brenneman to appoint Kent Wilson as third auditor, seconded by Ralph F Rispoli. Unanimous

A motion was made by Kenneth Brenneman to reimburse Michael Fay in the amount of \$220.46 for pump, seconded by Ralph F Rispoli. Unanimous Heather Flaig Abstained.

A motion was made by Kenneth Brenneman to reimburse Michael Fay in the amount of \$32.00 for a Washer and Hedge Trimmers, seconded by Ralph F Rispoli. Unanimous Heather Flaig abstained.

Daryl Cole spoke about Ganister and noted that the project would require a lot of money from the budget. He encouraged the board to consider ways in which the residents of Ganister would pay for the project rather than all taxpayers in the township.

Kenneth Brenneman spoke about electricity costs.

A motion was made by Kenneth Brenneman to direct Eleanor Harclerode to send a letter to Penelec to inquire about installing led lights in public fixtures, seconded by Heather Flaig. Unanimous
