ORDINANCE 61

AN ORDINANCE TO WIDEN A PORTION OF RECREATION DRIVE (T.R. 601) IN CATHARINE TOWNSHIP, BLAIR COUNTY, PENNSYLVANIA

WHEREAS, in the judgment of the Supervisors of Catharine Township, it is necessary and appropriate to widen a portion of Recreation Drive (T.R. 601) in Catharine Township, Blair County, Pennsylvania.

AND WHEREAS, Catharine Township is the owner of the lands which would be used to widen said Recreation Drive (T.R. 601) and the Borough of Williamsburg is the owner of all lands adjacent to the lands which would be used to widen said Recreation Drive (T.R. 601) and the said Borough of Williamsburg has petitioned and requested the Board of Supervisors of Catharine Township to widen Recreation Drive (T.R. 601).

AND WHEREAS, the Borough of Williamsburg has been given at least ten (10) days' written notice of the time and place when they may meet and be heard concerning this Ordinance.

AND WHEREAS, the proposed ordinance to widen said road has been advertised as provided by law.

NOW THEREFORE, Supervisors of the Township of Catharine in accordance with the powers granted unto them by The Second Class Township Code, as supplemented and amended, do hereby ENACT AND ORDAIN AND IT IS HEREBY ENACTED AND ORDAINED as follows:

1. The Township of Catharine hereby widens Recreation Drive (T.R. 601) by adding the following lands to said roadway:

LOT 3 A Portion of Tax Parcel 6-12A-2-34E To be conveyed to Williamsburg Borough

ALL THAT CERTAIN parcel of land situate in the Township of Catharine, Blair County, Commonwealth of Pennsylvania, bounded and described as follows: BEGINNING at a 5/8" rebar with cap set on the southerly boundary line of lands now or formerly of Catharine Township, said 5/8" rebar with cap being approximately 35 feet south of the corner of the right field fence of the baseball field; thence along the westerly boundary line of lands now or formerly of Williamsburg Borough the following three courses and distances: South 43°35'58" West, a distance of 72.72 feet to a point; South 43°47'49" West, a distance of 273.90 feet to a point; South 25°17'49" West, a distance of 212.52 feet to a point along the Frankstown Branch of the Juniata River;

thence along the Frankstown Branch of the Juniata River North 53°29'31" West, a distance of 65.98 feet to a point; thence through lands now or formerly of Catharine Township North 43°04'42" East, a distance of 42.37 feet to a 5/8" rebar with cap set at the southernmost corner of present Recreation Drive (T.R. 601); thence along the easterly right-of-way line of present Recreation Drive (T.R. 601) the following three courses and distances: North 43°04'42" East, a distance of 310.17 feet to a 5/8" rebar with cap set; North 36°30'32" East, a distance of 53.21 feet to a 5/8" rebar with cap set; North 20°40'52" East, a distance of 55.08 feet to a 5/8" rebar with cap set; thence through lands now or formerly of Catharine Township North 60°41'46" East a distance of 105.13 feet to a 5/8" rebar and cap set and place of beginning.

Said lands contain 0.230 Acre and are shown on a plan by Stiffler, McGraw & Associates, Inc. prepared for the Borough of Williamsburg.

- 2. A certified copy of this ordinance shall be filed in the Office of the Prothonotary of Blair County.
- 3. The effective date of this ordinance shall be five (5) days after the enactment and ordaining thereof.
