

CATHARINE TOWNSHIP ORDINANCE 91-1

AN ORDINANCE ADOPTING A PROPOSAL FOR THE CREATION OF
AN AGRICULTURAL SECURITY AREA WITHIN A PORTION OF
CATHARINE TOWNSHIP

Whereas, the Board of Supervisors of Catharine Township has received a proposal for the creation of an Agricultural Security Area under the Agricultural Area Security Law, Act of 1981, June 30, P.L. 128, No. 43 (P.S. Section 901 et seq);

And Whereas, said proposal for the creation of an Agricultural Security Area is for more than 500 acres of viable agricultural land;

And Whereas, notice of the receipt of said proposal was given as provided by law;

And Whereas, the proposal for the creation of an Agricultural Security Area was referred to the Blair County Planning Commission and to the Catharine Township Agricultural Security Area Advisory Committee as provided by law;

And Whereas, neither the Blair County Planning Commission nor the Catharine Township Agricultural Security Area Advisory Committee made any recommendation or proposed modifications to the proposal;

And Whereas, a public hearing relative to the proposal has been held as provided by law;

NOW THEREFORE, the Supervisors of the Township of Catharine in accordance with the Act of Assembly of 1933, May 1, P.L. 103, as supplemented and amended (53 P.S. Section 65101 et seq) known as The Second Class Township Code, and in accordance with the Act of Assembly of 1981,

June 30, P.L. 128, No. 43, as supplemented and amended (3 P.S. Section 901 et seq) known as the Agricultural Area Security Law, do hereby ENACT AND ORDAIN AND IT IS HEREBY ENACTED AND ORDAINED as follows:

1. An Agricultural Security Area within Catharine Township is hereby adopted for the following area:
