

MINUTES FOR THE JULY 15, 2021 MEETING OF THE CATHARINE TOWNSHIP BOARD  
OF SUPERVISORS

Catharine Township's regular monthly meeting began at 7:00 PM at the Catharine Township Municipal Building with supervisors Heather Flaig/Secretary, Kenneth Brenneman/Treasurer and Ralph Rispoli present. Road master Michael Fay was present.

Visitors: None

A motion was made by Ken Brenneman to accept the minutes as written for June 17, 2021, seconded by Ralph Rispoli. Unanimous.

A motion was made by Ken Brenneman to accept the financial report. Seconded by Ralph Rispoli. Unanimous.

The solicitor is looking into some options for action regarding the Barker Sewage issue. No other information available at this time.

Etna Furnace Road is in bad shape. Funds available, \$20,604.00, would only get approximately 2200 feet paved. Road Master to look into possible time frames to pave as much as we can at this time.

A letter was sent to the Blair County Commissioner's addressing the two county bridges on Etna Furnace Road and asking for the bridges to be inspected for safety. No response at this time from them.

Heather Flaig made a motion to adopt Ordinance #76, Weight Limit ordinance. Seconded by Ken Brenneman. Unanimous.

Blair County Tax Bureau wanted an updated list of the voting delegates for the township for the Blair County Tax Collection Committee. Heather Flaig made a motion to nominate Kalie Zabrosky and Melissia Lindemann, from the Williamsburg School District to represent Catharine Township. Seconded by Ken Brenneman. Unanimous.

Heather Flaig made a motion to approve of the address change from 732 Hillside Drive to 756 Canoe Mountain Drive. Seconded by Ken Brenneman. Unanimous.

PSATS Annual Business Meeting will be held October 14, 2021. No one plans on attending at this time.

American Rescue Plan (ARP) Funds were deposited into the Township's account. Half of the funds, \$35,628.70, were received 7-14-21. The other half will be received in a year. Guidelines for spending must follow the ARP Guidelines.

A letter was sent to the owners of the land that complained about for having a lot of campers by the road. July 4<sup>th</sup>, the property was looked at and there were only a couple of campers. No issue that day.
